A Paddock Observer will be appointed as a Judge of Fact in respect of the rules defined on article 27 of RMCGF2024 Sporting Regulations.

ARTICLE 4 - INSURANCES

In compliance with the legal prescriptions, the Organizer affects a Master Insurance Policy to indemnify the Original Insured's and/or Specified Parties in respect of all Third-Party claims made against them arising out of the circuit's Activities, Races, and Events, including all support events, practice periods and private hire of the venue for social and corporate events with a limit of indemnity of:

Public Liability: 25.000.000€;

ARTICLE 5 - PROTEST AND APPEALS

Amount of the Protest fee: 500 €

Amount of the Appeal fee set by ACI: 2.000 €

For reasons of operational necessity, the time limit for the presentation of protests during the qualifying, qualifying heats and pre-finals will be amended from 30 minutes to 15 minutes. Any protest must therefore be presented in writing to the Clerk of the Course or to his deputy within 15 minutes after the posting of the results of the Qualifying Practice, Qualifying Heats and Pre-Finals.

The time limit for presentation of protests during the final phase remains unchanged. That is, within 30 minutes after the posting of the classification of the races of the final phase.

In accordance with Article 12.3.4 of the International Sporting Code, time penalties imposed by the Panel of Stewards for infringements of the regulations are not susceptible to appeal.

7.1. The event will comprise non-qualifying practice, qualifying, qualifying heats, prefinal heats and final.

7.8 During Pre-Finals and Finals, any driver about to be overtaken or who has been overtaken by the race leader for any reason whatsoever will be shown the blue and red flag (double diagonal) with his starting number. He shall compulsorily go to the scales in the Parc Fermé and will be classified according to the number of laps that he has actually completed.

ARTICLE 8 – SUPPLEMENTARY CONDITIONS

8.1 For safety reasons the paddock will close according the official time schedule and it is prohibited to stay in the paddock after this time.

8.2. Fines: Fines imposed by the Stewards, according with the RMCGF 2024 Sporting Regulations must be paid immediately to the stewards.

After the event, organizer will send a copy of the receipt to Rotax and to ACI confirming the donation to the institution.

8.3. Passes: during the distribution of passes, on presentation of the corresponding license (Driver and /or Entrant and /or Legal Guardian), every driver and/or Entrant and/or Legal Guardian must sign for the receipt of the documents, thereby undertaking to respect all regulations (FIA, CIK-FIA, RMCGF 2024 Sporting and Technical regulations) as well as these supplementary conditions.

“Driver” and “Mechanic” passes will be issued at the Sporting Checks.

To access the facilities, it is mandatory for everybody the use of an event wristband, which will be supplied at the Sporting Checks by the Organizer.

Each Driver will get 4 wristbands. Additional passes may be requested, but they are subject to the availability at that moment.

Personal passes and wristbands must be presented at any time, and no one will be readmitted without a pass.

8.4. Race numbers: provided by the Organizer only.

8.5. Official Notice Board: will be digital, available on the Rotax Global App. The App is mandatory to be downloaded by the Entrant.

ARTICLE 9 - CODE OF CONDUCT (REMINDER)

The focus of the annual RMC Grand Finals is purely on sporting matters and we, Organizer and Promoter (BRP-Rotax), ask all participants and supporters to respect this. We do not represent any political position. Organizer staff, BRP-Rotax and the Rotax karting team want to point out that the RMCGF is a safe and neutral international sport event for all nations and we focus on the sport that we all love.

Also we remind all the Competitors, Entrants, Mechanics and everyone present in the RMCGF 2024 that, as per Article 1.2 of the FIA Statutes and Article 1.3 of the FIA International Sporting Code :

- That absolutely NO TOLERANCE for the manifestation of discrimination towards race, skin colour, gender, sexual orientation, ethnic or social origin, language, religion, philosophical or political opinion, family situation or disability will be accepted. This stance is applicable towards other Competitors, Entrants, Mechanics and all Officials.
- That discrimination linked to the above is a MAJOR infringement of the FIA International Sporting Code and is as such sanctionable.
- That also this event is meant to reflect the highest level of the sport of Karting.
- That FIA encourage anyone that suffers from discrimination to contact the event organizer and report the offence. Based on the offence, an official report will be made to the Event's Stewards for their consideration and potential act
